Urban Aboriginal Housing

- “Like a fire that lives under the moss, burning slowly and gently but with little smoke” *(Rodney Bobiwash, 1997)*
- Programs and projects have been in Canadian cities for decades.
- Many urban Aboriginal housing organizations had their start in the 1970s with roots in the friendship centre movement; others in the 1980s with CMHC’s development of the Urban Native Housing Program.
- Rent supplements and operating subsidies are the mainstay of the projects developed until recently.
- Like other affordable housing in Ontario, funding today for off-reserve Aboriginal housing is in the form of forgivable capital loans

Miziwe Biik Development Corporation

- Established in 2004 with a mission *“to serve as a vehicle for the economic advancement and self-sufficiency of the Aboriginal community in the Greater Toronto Area (GTA).”*
- Focus on business development and training, business loans/grants, and *affordable housing.*
- Conducted the Greater Toronto Area Aboriginal Housing Consultation (Final report – 2008)
- Selected to be the Program Administrator to deliver the *GTA Aboriginal Housing Program*
- “Aboriginal housing under Aboriginal control”
- Continue to use the findings of their consultation in the delivery of housing programs.

GTA Aboriginal Housing Program

- Federal and provincial funding
 - **Initially:** Off-Reserve Housing Trust funding
 - **Now:** Investment in Affordable Housing (IAH) for Ontario Program funding
- Three original program components:
 - Aboriginal Rental Program-GTA
 - Aboriginal Downpayment Loan Program-GTA
 - Aboriginal Home Repair Program-GTA
- Current funding is until 2020:
 - \$11,017,900 over six years (2014-2020) to be targeted to the **Rental Program** and the **Home Ownership Program**

Affordable Rental Program

- Interest-free, forgivable loans to non-profit Aboriginal Service Providers
- \$150,000/unit available of capital construction, renovation or conversion
- Units developed must be targeted to Aboriginal households off-reserve and in the GTA
- Target groups (in order of priority):
 - Large families*
 - Small families*
 - Seniors and singles*
 - Victims of domestic violence
 - Persons with disabilities
- Rents below or at 80% of AMR, tenants to pay minimum of their income on rent.
- All utilities included.

Constraints... Opportunities...

- Land acquisition and high capital costs in the GTA
 - *Funded programs have included renovations*
- Individuals and families must be able to pay up to rents at 80% of AMR.
 - *Provider can seek rent supplements/allowances*
- Program administration and legal costs can be passed on to provider.
- Limitations to program stacking.
 - *Partners can bring things to the table*

Successes!

- At least **8 projects** funded for a total of **143 units** of affordable rental housing for Aboriginal individuals and families.
- More than **\$21,000,000** in funding towards *affordable rental housing projects owned and operated by local, community based, non-profit Aboriginal organization.*
- Combination of new construction and acquisition/rehab projects
- New homes in **Toronto, Brampton and Oshawa**
- Current funding carries through until 2020 and can be used for new builds, home ownership, rent allowances
