WHO IS ELIGIBLE?

Any active CSCMP member who is age 32 or under at the time of the nomination deadline, April 15, 2019.

NOMINATOR RESPONSIBILITIES

Nominators need to provide a descriptive summary of the nominee's achievements and contributions in 500 words or less. Nominees will be evaluated based on the following criteria.

- Active involvement in CSCMP
- Certifications and continuing education
- Recognition as an up-and-coming leader
- Contribution to the supply chain management profession

The summary should describe specific aspects of the nominee's business and professional experiences, providing specific examples. The nomination submission must also include one letter of recommendation written in support by members of the supply chain management discipline. Letters of recommendation written by current members of CSCMP's Board of Directors are not admissible.
